**ORDINANCE NO. 7  
Series of 2010**

**AN ORDINANCE APPROPRIATING THE AMOUNT OF SIX MILLION ONE HUNDRED ONE THOUSAND ONE HUNDRED SIXTY SEVEN PESOS AND TWELVE CENTAVOS ( Php 6,101,167.12 ).**

**Be it enacted by the Sangguniang Bayan in session held at the session hall, that:**

**SECTION 1. TITLE.** This ordinance shall be known as the ‘ General fund Supplemental Budget No. 3 FY 2010’.

**SECTION 2. SOURCE OF FUND.** The sum of Php 6,101,167.12 shall be taken from the Personal Services Savings and the unappropriated surplus amounting Php 6,102,669.04.

**SECTION 3.** The sum stated in the immediately preceding section is hereby allocated for the following items: Productivity Enhancement Incentives; Additional Travelling Expenses; Additional accountable forms; Additional cash tickets; Additional maintenance and Other operating expenses; Loyalty cash award; Skills enhancement for Senior Citizens; One Unit Printer (LQ 300 ); and One Unit Digital Camera.

- 3. Certification as to surplus signed by Vilma Ubalubao, MTO and Josephine Almario, OIC Accountant.**
- 4. Statement of Supplemental Appropriation, of two pages, signed by Mayor Felipe Neri N. Yap and Rita C. Jinio, MBO.**
- 5. Statement of Productivity enhancement incentives: of two pages, signed by Mayor Felipe Neri N. Yap and Rita Jinio.**

**SECTION 5.** No funds hereto appropriated shall be transferred to any other purpose unless authorized by the Sangguniang Bayan in a subsequent action;

**SECTION 6.** Disbursement of funds hereto appropriated shall be made in accordance with the usual accounting rules and regulations;

**SECTION 7.** This ordinance shall take effect immediately upon approval.
