**ORDINANCE NO. 8

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE MILLION ONE HUNDRED TWENTY - THREE THOUSAND PESOS (P1,123,000.00).

Be it enacted by the Sangguniang Bayan in session held at the Municipal Session Hall:

SECTION 1. This Ordinance shall be known as “THE GENERAL FUND SUPPLEMENTAL BUDGET NO. 4 FY 2010 OF THE MUNICIPALITY OF IVISAN”.

SECTION 2. The sum of P1,123,000.00 shall be sourced from the unappropriated surplus of 2010.

SECTION 3. The sum stated in the immediately preceding section is hereby appropriated for the following: 1.) Additional Productivity Enhancement Incentives, FY 2010 2.) Financial Assistance to: a.) 80 Job Order (Laborer) @ 1,000.00 and 5 NGA’s.
